Subject: Twin Comanche Modifications

Models Affected: PA-30 Twin Comanche

Serial Numbers Affected: 30-1 to 30-2000 incl.; Airspeed Markings and Revised Operating Practices Recommended by the Manufacturer Placard.
30-1 to 30-1716 incl., 30-1718 to 30-1744 incl.; Stall Warning Horn Installation.

Compliance Time: Immediate; Airspeed Markings and Revised Operating Practices Recommended by the Manufacturer Placard.

Prior to but not later than August 1, 1970; Stall Warning Horn Installation.

Purpose: To provide material and instructions to accomplish the following listed modifications on the above referenced aircraft.

I. Airspeed Markings and Revised Operating Practices Recommended by the Manufacturer Placard Installation, Kit No. 760 408.
II. Stall Warning Horn Installation, Kit No. 760 373.

Instructions: Installation instructions for Items I and II above are contained in the appropriate kits.

Material Required: Airspeed Markings and Revised Operating Practices Recommended by the Manufacturer Placard Installation, Kit No. 760 408.

Stall Warning Horn Installation Kit No. 760 373.

NOTE: Material for compliance with Item I (Purpose) is enclosed.

Availability of Parts: Stall Warning Horn Installation Kit No. 760 373 - Piper dealer (limited availability until June 1, 1970).

(end of quote) Disregard this Purpose when the counter rotating powerplant conversion is installed in accordance with the installation instructions contained in the conversion kit reference Service Letter No. 552.
